The board presents the main events and accomplishments of 2023. One of those accomplishments was the development of a long-term strategic plan together with the clubs. The main points that are part of this strategic plan are shared.

- Compliments to the developments at the top sport level. Especially the outreach by the men's field U20 team is appreciated.
- Call to all clubs to consider how they present themselves and how they can professionalize in that. With support from the NLB, Amsterdam was able to establish a partnership with Pioneer. They would encourage every club to look into the opportunities with Pioneer. It leads to a lot of free marketing with the club logo being on show around town as well as gives credibility to the club.

Pioneer supplies merchandise as well as team uniforms. If clubs are interested in a partnership with Pioneer, reach out to Nate for help with contact and coordination.

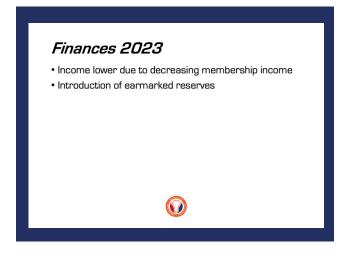
• Is recruiting students something the NLB is putting actions towards or is this still responsibility of the clubs?

In the end recruitment is and will be a responsibility of the clubs. But the board is looking for ways to provide more support from a national level.

Not everyone was able to open the letter of the financial committee that was sent. The treasurer briefly presents the most important points that are made by the financial committee in their letter.

The change of book year poses new challenges, as our organization is organized in seasons. To keep the financial structure as clear as possible, the NLB will count income received in the calendar year to that year, rather than spread this over the current and next year. This does create a bit of a risk, since it makes income from membership harder to predict. Most of this revenue is generated in September.

The treasurer role has become more and more labor intensive. There is a need to streamline processes and standardize workflows to reduce the workload on the treasurer. BondCenter is a huge help in this process as they have knowledge of best practices with other federations. The financial committee is supportive of the investment in BondCenter services.

It would be desirable to have an invoicing model that links to LeagueMaster. There is currently a large backlog in membership payments from clubs to the NLB. To make this process run more smoothly it is important that clubs are very diligent in checking the administration and registration of members in league master.

• Is payment through LeagueMaster a service that is provided? This is a very complex integration. If it is not already part of the application, we shouldn't bank on this integration happening shortly.

The board is in talks with LeagueMaster about potentially developing this. Depending on the complexity and associated costs, the board will consider applying for a new grant from World Lacrosse. The initial development of League Master was also covered through a World Lacrosse grant.

Starting in 2024 top sport programs will also fall under the NLB, which will again increase the work load for the treasurer. The financial committee will start to take on a more active role in support of the treasurer. Differently from other income, the income of the top sport programs will be reserved and counted towards the year that the championship occurs.

The conclusion of the financial committee is that the NLB is financially healthy. The financial committee is convinced that the financial report is accurate and an accurate representation of the financial activities in 2023.



Other than the above the financial report shows that we started working with earmarked reserves or special projects. These are projects for which we have received grants that get withdrawn from over multiple years

The financial report also shows a high number of debtors at end of year. It is important that we reduce this. The main cause of the number of debtors is delays with invoicing due to memberships registration issues. We still haven't settled all of these.

"Overlopende active" in the report are contributions received for the national teams that are counted towards the following year.

• where can we find the income generated from officiating courses?

• The budget included € 16.000 for TNL, but that was never transferred. It ss surprising that it was cut

That is correct. The reason is on the one hand that there were many different teams that year which made us worry about the money being diluted too much too make an impact if there was no clear policy for the investment. At the same time we were making plans to bring top sports back to the NLB and for TNL to dissolve. It didn't make sense to transfer this money back and forth. TNL also shared that the teams already had large reserves. WDNT \leq 25.000, MDNT \leq 10.000, BOX \leq 15.000. The board is still working with TNL to receive a a last balance with the exact amounts.

• Can you call those large reserves? The top sport teams each have a bigger revenue and less reserve than the rest of the NLB

This summer the board hopes to have a technical director, which depends on today's voting, to then work with the teams on a clear strategy for the spending on top sport. We will invest in top sport but it has to be a well-considered.

• We agree that streamlining is necessary, and it is a huge step of professionalization that we now fall under the NLB. But it is a big sum to not invest. The top sport programs were never asked to provide a policy.

We recognize that this can be considered disappointing. As a board we want to focus on transparency moving forward

• Is there a strategy to allocate these funds for the future?

This is what we want to develop this summer, hopefully with the technical director coming on board.



• When is that conversation going to start. We have 3 big tournaments going on this summer. It would be helpful to know what help we will get from the NLB?

As soon as possible. But we cannot promise a decision before the tournament.

• What is the information you need from the national teams?

This is why the board is hoping to add a technical director to the board. To sort these sorts of things. We don't have the answer right now. We want to unify and have oversight and understanding. The goal is to figure out how we can stretch the money to have as much impact as possible

4. Board appointments

According to our articles of association the board may present candidates for appointment and reappointment to the NLB board. The president is voted on in his position. All other board members are appointed as general board members. The board than assigns roles among themselves.

The board proposes to reappoint Tom Thayer in his position as president of the NLB board. Tom shares that he wants to keep going. The NLB is facing a lot of challenges: administration, members, top sport incorporation. He doesn't want to leave something in a worse state. He wants to step away when there is a positive trajectory. He really enjoys it and appreciates it. Not speaking Dutch is sometimes a limiting factor, but he hopes the clubs can still stand by him

The board proposes to reappoint Friede Berendsen, Helga Lasschuijt and Lyle Worthington as board members of the NLB.

The board proposes to appoint Jorik van Baal as a board member of the NLB. He will fulfil the role of technical director ion behalf of the NLB. That means that he will primarily focus on the development and management of the top sport programs of the NLB.

Jorik had been the coordinator of breedtespor for the last years. He is eager to join the board and take on this new challenge.

• Jorik oversaw breedtesport up to now. Who will do that from now on?

Channa Jonkers is currently the division manager for the second and third division women's and wants to step into that spot. She already has a few seasons of experience in the breedtesport committee, so we believe that is a good fit.

5. Kascommissie

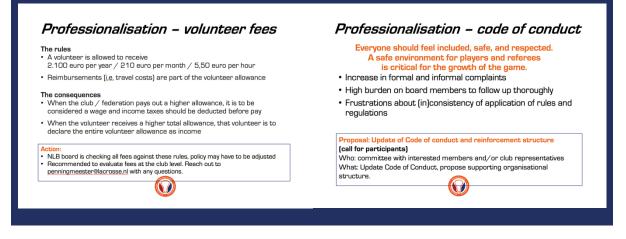

6. Update 2024



The board wants to share several projects and topics that they are currently working on or that they would like to start working on.

The first topic is volunteer allowances.

The Belastingdienst is cracking down on sports organizations. NOC*NSF has been sharing a lot of knowledge on the tax regulations we have to adhere to. The most important thing we believe clubs need to be aware of is the regulations regarding volunteer allowances. A volunteer fee may be maximum \notin 5,50 per hour, to a maximum of \notin 210 per month, to a maximum of \notin 2100 per year. This allowance includes any expenses like travel costs. If a club or the federation pays out an allowance that accedes these amounts, they are to be considered a wage and income taxes should be deducted before payment.



The NLB is checking all volunteer allowances against these rules and will determine if any policies need to be adjusted. The board encourages the clubs to do the same. If clubs have any questions regarding this topic they can reach out to Helga.

Another thing the board is looking into is an update of our code of conduct. Recently the board has been getting formal and informal signals of misconduct and even aggressiveness, between players and toward officials. At the same time the board is realizing that they are not equipped to deal with such signs in a swift and consistent manner, as any complaint now have to be dealt with by board members on top of the rest of their workload.

The board wants to make sure the increase in formal and informal complaint, and therefore the suspected increase in misconduct, does not take hold within the culture of the sport. For that it is necessary to update the code of conduct and to consider what structure is needed to make sure any complaints are handled appropriately. The board is asking the club boards if they or members of their clubs may be willing to work on this.

• Earlier in this meeting there was a discussion on the lack of volunteers. How is asking for volunteers the solution to this problem?

Though the board is aware of the lack of volunteers, they still want to provide an opportunity to the members to think along in this process, rather than present a finalized product at a next general assembly. Volunteers from the membership are much appreciated but not a must.

• The increase of complaints is a surprise and not something that is recognized. But didn't we have a complaints committee in the past?

We did have a structure to deal with complaints like these. Hoewever, it no longer exists.

• Wasn't there an external person?

You are talking of the vertrouwenscontactpersoon. This is someone you can reach out to for complaints about things like sexual intimidation or aggression. The vertrouwencontactpersoon is not involved for infractions of i.e. our competitions regulation.

As mentioned earlier in the meeting, the board is looking for ways to support club recruitment centrally. They are talking to someone who is willing to take up that role over summer. Please share a contact person of your club for recruitment, so that when we have everything in place this person can reach out to them.

• Is this a paid position?

It will be a volunteer position that also includes several other tasks for which we will provide an allowance.

• Clubs would be helped with a good new video presenting lacrosse to potential members. Is this something that the NLB could work on.

Great idea. That is definitely something to look into. And please keep sharing these sorts of suggestions, we want to explore this sort of idea.

Then lastly the board wants to look into the further development of officiating in the Netherlands and what that should look like. The level of officiating has risen and is really something to be proud of. But we think there is a need to evaluate. Earlier concerns by clubs regarding the costs of training have not yet been addressed. Stories of officials being treated badly and even threatened are concerning. And at the same time the cost of officials is high in relation to our overall budget and needs to be looked at. The board is calling for volunteers to help us develop several scenarios regarding the development of officiating.

• what is the benchmark based on?

We did a benchmark a little while back comparing the budgets of the NLB with those of several other federations for team sports in the Netherlands, both big and small. This included the federations for hockey, basketball and a few more.

• It is important to note that in lacrosse there are more officials on the field.

The benchmark is just on the slide to provide context, not a goal. The board just feels there needs to be a good overall consideration of how we approach officiating and the future development of officiating in the Netherlands. We will do what is best for the sport.



7. Game time adjustment

MH&LC Tempo Ogers has asked to include a vote for game time adjustment for the general assembly. The proposal is to change the game time for men's field lacrosse to four quarters of fifteen minutes with a stop clock, as opposed to the current four quarters of twenty minutes running clock.

- Ogers are proposing this change for multiple reasons: more uniformity with international rules, to increase the intensity of the games and to improve the scheduling of gamedays. The current gamedays last too long. Most importantly the shorter games will lead to more focused and intense play.
- There is something to say for a switch to four times fifteen minutes, especially with the trend to smaller teams since covid. Especially in the second division teams are struggling with numbers and players must conserve energy so that they still have gas in the tank towards the end of the game. But why are Ogers proposing to include the stop clock, rather than a full shift to the World Lacrosse rules.
- Oger proposed a full switch to international rules at a past general assembly. That proposal got voted out. The addition of the stop clock is an attempt to find middle ground.
- The fact that players are not fit enough is not something we should base this decision on.
- That is true. But also at the top sport level the 4x15 format leads to more intense games. Each second of the game is more important.
- Disagree that shortening the quarters will get people to go harder from the start, it just changes how you conserve energy. In the first division that was already only 5 teams, which means less games per season. Taking away another 20 minutes per game again decreases play time. The goal is to improve out level of play and for that play time is needed.
- Wageningen took the liberty to time the dead time during the finals game. That totaled to about 5 minutes per quarter. Stop clock will therefore not shorten the total game time and only make the overall duration of the game less predictable. It is also more work for the bench.
- Utrecht is not favorable to reduction of play time, especially for larger teams. Stop clock makes the game time unstable and might even slow down the game because the running clock stimulates to restart the game quickly.
- It is important to protect players health, especially with larger teams. Were di is working on a proposal to increase the number of games per season in the competition. This will allow for us to decrease time per game.
- There was an argument about stop clock being difficult for the bench. Once again, this shouldn't be something we should base this decision on. That just means we have to work on education for the bench.
- Utrecht would be favorable to more games per season. In that case they are open to decrease time per game.



- It is important to repeat that following through on this proposal with the stop clock does not actually make a difference in game time.
- The Ogers are doing this proposal because they want to increase the intensity of the games, they are not aiming for less lacrosse. The proposal would provide more true playing time.

8. Q&A

• Keizerstad Kannibalz is once again hosting the newcomer's tournament in September. Please spread the word. They would also like to invite the NLB to hold an in person ALV during the tournament. They can arrange for the necessary facilities.

Thank you for hosting the tournament and the invite.

• What are the plans for sixes in competition and tops port?

We are looking to develop a sixes program that is separate within the top sport domain, but players need to be able to also play other disciplines. Aiming to get a call for coaches out shortly, so we have staff sorted by end of summer.

There are no plans to incorporate sixes in the regular competition at this time. This was discussed at an ALV last year. The outcome was that sixes would remain event-driven for now. So that is how it is currently being rolled out.

An email went out a few weeks ago asking about team sign-ups for next season. Answers were received from about half the clubs. The deadline is tomorrow. Please reach out if you have question or need help. We are looking at transforming the competition to add more games and higher competitiveness, but we need information so please inform us.

• Utrecht asks to reconsider the competition rules regarding the four-game requirement for participation in the play-off games, especially for the lower divisions. Now there is no way to get an exemption, which meant that we had trouble getting enough players together for the weekend. But maybe if we could allow for emption requests in February already that may be a solution, as it is especially difficult to meet this criterium for players that join halfway the season.

Thanks for the suggestion. We are working on rewriting the competition rules and will definitely take this into account.

• In the past the coordinator breedtesport was very eager to hand out fines. There have been little rumors about fines recently. Are we doing better?



It sounds like you are referring to a specific incident. Let's take that conversation outside of this meeting. In general, it is our goal to keep people enthusiastic about playing and handing out fines is does not contribute to that.

To conclude with a big announcement:

The king and queen are currently traveling through New York. We had an opportunity for two of our coaches, Neal Powless and Arttu Sesselaar, to meet with them yesterday. They were able to have a conversation about lacrosse, the Olympic inclusion and the king even got gifted a lacrosse stick. There are photos, but those are not available yet.

Additionally, there were opportunities to meet with governors and other officials. The king walked around with the lacrosse stick for the rest of the evening. It would really be great to push this for some media attention.
